In pursuance of Notification No.035-BOPEE of 2024 dated 24-06-2024, the **Provisional Merit List/result** of the eligible candidates for admission to **B.E./B.Tech. Courses-2024** in the various Government/Private Institutions of the Union Territory of J&K was issued for inviting objections, if any, from the concerned candidates whose result has been notified by the Board vide above referred Notification. No objection about the **Merit List/result** has been received by the Board.

The Board shall conduct the **1st Round of Physical Round of Counselling** for the **B.E./B.Tech. Courses-2024** at the BOPEE Offices Jammu/Srinagar simultaneously for allotment of seats to the candidates as per the following schedule: -

**Note:**

- All the participating candidates are hereby informed that they are required to bring along the following original documents on the allotted date(s) of counseling, otherwise they shall not be allowed to participate in the counselling process:
  - 12<sup>th</sup> Class Marks Card.
  - Domicile Certificate of UT of J&K/Ladakh.
  - Category Certificate, including TFW, if any.
  - Date of Birth Certificate (Issued by J&K Board of School Education / Centre Board/other Boards)
- Candidates shall have to report at the BOPEE offices Jammu/Srinagar physically for registration/attendance & fulfillment of other formalities between **08:30 a.m. to 10:00 a.m** on the day/date of their counselling.
- All the participating candidates shall have to deposit the counseling fee of Rs. 1000/-(one thousand only) through POS machine available at BOPEE office

Jammu/Srinagar through Debit/Credit cards. Any candidate who fails to deposit the counseling fee shall not be allowed to participate in the counseling process.

4. A candidate who fails to participate in his counselling on a particular (designated) date, shall, however, be allowed by the Board to participate in the counselling process on the next day; provided that he/she **does not stake any claim** on a seat which was available on his/her date of counseling but has already been allotted to a candidate figuring next in the order of merit list, on the grounds that the concerned candidate could not participate in the physical round of counselling earlier when the seat was available.
5. The candidate(s) who **fails to join in the allotted College** after completion of the counseling shall not be eligible to participate in the subsequent rounds of counselling i.e. upgradation rounds.
6. Seat Matrix shall be uploaded separately in due course of time before the date of Counselling.
7. The candidates must remain in constant touch with the official website of the Board i.e. [www.jkbopee.gov.in](http://www.jkbopee.gov.in) for any updates about the Counselling Process and the daily based Seat Matrix.
8. Any candidate who may not be able to attend counselling physically **owing to a specific valid reason** can **authorize a person** (through Authority Letter-on prescribed format available at the BOPEE office Srinagar/Jammu) from his/her family member(s) to participate in the counselling process on his/her behalf at the BOPEE offices Jammu/Srinagar on the day/date of counselling as per his/her Rank with valid ID Proof.
9. The Board reserves the right to notify any such change(s) as may become imperative in view of any technical difficulty or the reasons which are beyond its control.

The other Terms and Conditions as notified through the Information Brochure, Notification(s)/Notice(s) issued by the Board in this regard from time to time, shall, however, remain the same.
